Official Sweepstakes Rules

NO PURCHASE OR FEE NECESSARY TO ENTER OR WIN. SWEEPSTAKES ONLY OPEN TO INDIVIDUALS WHO AT TIME OF ENTRY ARE RESIDING IN THE 50 CONTINENTAL UNITED STATES AND WASHINGTON, DC, WHO ARE 18 YEARS OF AGE OR OLDER, WHO CAN LEGALLY POSSESS, OWN AND USE A FIREARM AND PARTICIPATE IN HUNTING ACTIVITIES UNDER FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS, AND WHO HAVE INTERNET ACCESS AND A VALID EMAIL ADDRESS. SWEEPSTAKES VOID WHERE PROHIBITED OR RESTRICTED BY LAW. SWEEPSTAKES SUBJECT TO ALL APPLICABLE FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS AND OTHER RESTRICTIONS ESTABLISHED IN THESE OFFICIAL SWEEPSTAKES RULES OR BY SWEEPSTAKES ORGANIZER.

Participation constitutes entrant’s full and unconditional agreement to and acceptance of these Official Sweepstakes Rules.

Eligibility: No purchase or fee necessary to enter or win. The WingshootingUSA “Win A Shot On The Show” Sweepstakes (“Sweepstakes”) is open only to individuals who at the time of entry are residing in the 50 continental United States including Washington, DC, who are 18 years of age or older, who can legally possess, use and own a firearm and participate in hunting activities under federal, state and local laws and regulations, and who have Internet access and valid email addresses. Sweepstakes void where prohibited or restricted by law. Sweepstakes subject to all applicable federal, state and local laws and regulations and other restrictions established in these Official Sweepstakes Rules or by Sweepstakes Organizer. Employees, officers, directors and other representatives of Sweepstakes Organizer, Grand Prize Sponsor, and host hunting preserves, and their respective relatives or household members, not eligible to enter or win.

Sweepstakes Period: Sweepstakes begins 12:01AM (ET) on September 28, 2009 and ends 11:59PM (ET) on April 15, 2010 (“Sweepstakes Period”).

How to Enter: To enter Sweepstakes, visit www.wingshootingusa.org during Sweepstakes Period to complete an official WingshootingUSA survey/entry form. No other method or form of entry accepted. Entry forms must be received by Organizer no later than April 15, 2010. Incomplete entry forms or entry forms not received by Sweepstakes Organizer by entry deadline shall be ineligible. Limit one entry per household during Sweepstakes Period. Multiple entries and entries from persons of same households shall be disqualified.

Prizes:

Grand Prize: One (1) eligible Grand Prize winner will receive:

- One (1) pair of ESP Hearing Protection for Grand Prize winner (ARV \$795.00)
- Two (2) day/one (1) night hunt for Grand Prize winner and his/her son or daughter at an upland bird hunting preserve during the 2010 broadcast season of WingshootingUSA TV. The location and date of the hunt will be determined by Sweepstakes Organizer based on the WingshootingUSA TV 2010 broadcast season production schedule. If Grand Prize winner does not have children, he/she may invite a friend and the friend’s son or daughter to accompany Grand Prize winner on hunt. Only one child permitted. All invitees must be physically capable and legally eligible to possess and use a shotgun or rifle under federal, state and local laws and regulations where hunt will occur. On the hunt, Grand Prize winner and guest(s) will be joined by WingshootingUSA TV host Scott Linden and his production crew. Grand Prize winner and his/her guest(s) will be filmed and appear on an episode of WingshootingUSA TV to be aired sometime in 2010. Grand Prize includes roundtrip coach airfare, ground transportation, meals, guide service and lodging for Grand Prize winner and his/her guest(s) (ARV of Hunting Trip: \$2,795.00 (For Two People) or \$3,795.00 (For Three People). Grand Prize winner responsible for obtaining all hunting licenses, if required. All other expenses not specifically identified in these Official Sweepstakes Rules to be borne by Grand Prize winner and his/her guest(s). Grand Prize provided by Linden Media Management (“Grand Prize Sponsor”).

Runner-Up Prizes: Four (4) eligible winners will each receive a \$500.00 gift certificate to a wingshooting preserve of their choice in their respective state of residency – hunting preserve must be listed on www.wingshootingusa.org (ARV of Runner-Up Prize Pool \$2,000.00). All hunts must occur before April 15, 2011. Sweepstakes Organizer retains final approval of all hunt locations selected and hunt arrangements. Runner-Up Prize winners responsible for paying their own expenses and any balance due on hunt fees.

All prize winners must conform to all federal, state and local firearms and hunting laws and regulations. All hunts are subject to rules and regulations of the host hunting preserve. Federal, state and/or local taxes on prizes, if any, are the sole responsibility of the winners. No transfer, assignment, cash redemption, or substitution of prizes except by Sweepstakes Organizer who may substitute prizes as necessary. All prize details are at the sole discretion of Sweepstakes Organizer.

Odds of Winning: The odds of winning a prize depend on the number of eligible entries received.

Winner Selection: Winners will be selected at a random drawing on April 30, 2010 at Sweepstakes Organizer’s headquarters and will be notified by email. Winners need not be present at drawing. Grand Prize winner shall be drawn first followed by Runner-Up Prize winners. If a selected winner is unreachable, fails to claim prize within seven (7) business days after notification, or is determined ineligible, the winner will forfeit his/her prize and prize will be awarded to an alternate winner. All potential winners are subject to verification by Sweepstakes Organizer before prizes are awarded. In order for a winner to claim a prize, Sweepstakes Organizer, Grand Prize Sponsor and/or individual host hunting preserves may require additional information or documentation to prove Sweepstakes eligibility, including without limitation, proof of identity, age and US residency.
