The Firearm and Ammunition Industry Economic Impact Report

This report details the significant economic impact the firearm and ammunition industry has on our economy, both nationally and at the state level. The economic growth America's firearm and ammunition industry has experienced in recent years has been nothing short of remarkable and has been driven by an unprecedented number of Americans choosing to exercise their fundamental right to keep and bear arms. This includes an estimated 3.9 million new gun owners in 2024.

The report also highlights the significant impact the firearm and ammunition industry has on wildlife conservation funding in America through its growing Pittman-Robertson excise tax contributions to the Wildlife Restoration Trust Fund, which exceeded \$886 million in 2024. Since 1937, the industry has paid nearly \$29 billion into the fund since its inception in 1937, when adjusted for inflation.

Regardless of economic conditions across the country, the industry is consistently growing and generates nearly 383,000 well-paying jobs. The industry is proud to be one of the bright spots in our economy.

Manufacturers of firearms, ammunition, and supplies, along with the companies that sell and distribute these products, provide well-paying jobs in America and pay significant amounts in tax to the state and Federal governments.


The Firearm & Ammunition Industry is an Important Part of America's Economy

Companies in the United States that manufacture, distribute, and sell firearms, ammunition, and hunting equipment employ as many as 150,668 people in the country and generate an additional 232,327 jobs in supplier and ancillary industries. These include jobs in supplying goods and services to manufacturers, distributors, and retailers, and those that depend on sales to workers in the firearm and ammunition industry.1

These are good jobs paying an average of \$68,300 in wages and benefits. And today, every job is important. The United States currently has an unemployment rate of 3.40 percent. This means that there are already 6,984,000 people trying to find jobs in the nation and collecting unemployment benefits.²

The Economic Benefit of the Industry Spreads Throughout the Country

Not only does the manufacture and sale of firearms and hunting supplies create good jobs in the United States, but the industry also contributes to the economy as a whole. In fact, in 2024 the firearm and ammunition industry was responsible for as much as \$91.65 billion in total economic activity in the country.

Not only does the industry create jobs, it also generates sizeable tax revenues. In the United States, the industry and its employees pay over \$10.97 billion in taxes including property, income, and sales based levies.³ Of the \$941.8 million in excise tax paid to Pittman-Robertson Wildlife Restoration Fund in 2024. \$886 million came from firearms and ammunition.
